

MEMBERSHIP PRIMER:

I have received many comments from prospective members and candidates concerning the process of becoming a member of our Lodge. I thought it might be helpful to remind everyone of the steps we each have taken to become a member. If you have any questions, please contact Lodge Secretary Jan Sullivan.

- 1. An application blank must be completely filled out and given to the Lodge Secretary, with the application fee of \$40. If the candidate is under the age of 26, their application fee is only \$20.
- 2. The Application blank has confused some of our members. The member *proposing* (i.e., sponsoring) the new candidate must fill in the top portion of the blank, where it says "Proposer." The candidate fills in the remainder starting with "Proposes."
- 3. The Secretary will send the candidate a letter enclosing a Receipt showing they have paid the application fees, and entitling them admission to the lodge during their candidacy.
- 4. The application will be read at the next meeting after it is received. The second meeting after receipt, the candidate will be voted on.
- 5. After the ballots have been cast, and the candidates elected, the Secretary will send a letter setting forth the date for their orientation and initiation, and telling them the amount of their pro rata dues for the remainder of the year. Until they get that letter, or an email, they are not to show up for initiation. We may have one while they are in process, but it does not mean all new candidates are ready for initiation. All members are encouraged to attend the initiation.

News from the Trustees (Roy Seabolt, Chairman) roy.seabolt@gmail.com



For those who have read my articles in the past, I have emphasized that I strongly believe that if we as Elks are going to survive as a charitable organization, we need to change our business model. We need to find new sources of revenue since the old revenue streams are either disappearing or declining. Let me give you an example. We have two very worthwhile charitable causes, the Backpack Lunch Program for school children in need where we pack approximately 80 lunches monthly so the children have food to eat on weekends. There is also the Veterans USO Food Delivery Program where we deliver food, twice a month, to the USO at Reagan National Airport for veterans and active military personnel where they can grab something to eat while

traveling. Both programs were originally funded with grants awarded by the Elks National Foundation. This year, we did not receive a grant for either program, so the programs are being funded directly by our Lodge. Finding new grants and funding will be critical in the continuation of these programs. Another way that we can change how we do business is to start partnerships with other organizations so that we are not assuming all the financial burden. Recently, during the Thanksgiving Food Basket Program, a non-profit group provided linens and other household items that the recipients of the Thanksgiving food baskets could take with them, along with the food and coats our members had provided. For the month of December, we have a partnership going with the World Tavern Poker League (our Saturday night poker group) where approximately 5 poker venues are collecting canned food each week from the participating players and donating them to our Lodge for distribution to those in need. By the end of the drive, we will have collected over 500 pounds of food. This food will be donated in January when holiday giving has ended and the families need it most. As I frequently say, it is nice that we donate the Thanksgiving baskets, but people are not just hungry around the holidays -- they need to eat, all year. In January, we will join at least one (possibly two) local Chambers of Commence with the goal being to develop additional business partnerships to help us complete our charitable goals. Many of these businesses have grants available to non-profits and they may be a source for recruiting new members. Finally, as we start to develop these partnerships, it is also important to improve our public relations outreach so that the non-Elks community becomes more aware of all the important work we do.
