MEMBERSHIP There have been many reports of misinformation concerning our application process being given out, which has slowed the application process for some, and caused some to just not continue their membership.

PLEASE NOTE: (1) A membership application is to be accompanied by the application fee of \$40 for all members who have passed their 26th birthday. It is \$20 for persons under that age. The application cannot be entered into the system until the fee is paid. (2) There is no formal investigation, such as for a government position, or a security clearance. According to the Manual for the Investigation/Interview Committee:

The examination should reveal if the applicant:

1. Meets the qualifications for membership as set forth in the Constitution and Laws of the Order.
2. Understood each of these questions.
3. Answered the questions on the application form truthfully.
4. Understands and agrees with the purposes of the Order.
5. Is socially and financially acceptable.
6. Intends to participate in Lodge programs.

We have trimmed our delinquent list to 31 members! Thank all of you who have contacted me concerning some of the members on the list, and even though I have been told that some may not be renewing, unless I hear from the member himself, I cannot remove them from the list based on supposition.

PLEASE NOTE: If you have not contacted the secretary by February 28, 2014, your name will be removed from the Membership roster. If you are dropped from membership, you will need to apply for reinstatement and you will be charged a reinstatement fee.

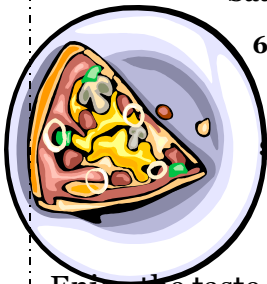

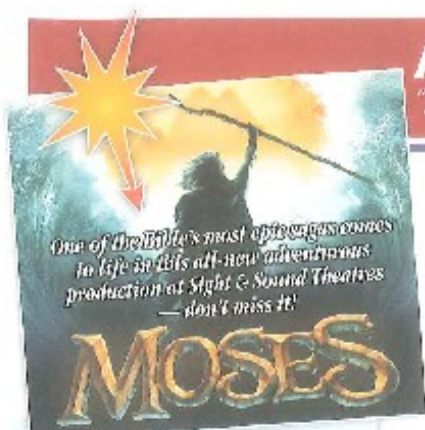
